Building Inspector/Code Enforcement Officer Report

BI/CEO Charlie Floeser explained his report.

NYStretch was also discussed. Further discussion to be held. Explanation of what NYS Energy Stretch Code:

"NYStretch Energy Code – 2020* Version 1.0 (NYStretch) is now available. NYSERDA developed NYStretch as a statewide model code for New York jurisdictions to use to meet their energy and climate goals by accelerating the savings obtained through their local building energy codes. For jurisdictions that adopt it, NYStretch will provide savings of roughly 11% over the 2020 Energy Conservation Construction Code of New York State (2020 ECCCNYS) when that energy code is released by New York State Department of State."

Town District Operator Monthly Water Report

Highway Superintendent Sokolofsky distributed and explained the below water report.

Water report: Town of Lima 7-6-2021

District #1 Sample: negative, chlorine Residual 0.07% No issues as of Last month.

District #2 service for Meadowlark Park has been detected but no shut off was found scheduled to be located next week and meter pit installed.

District #3 Sample: negative, chlorine Residual 0.07%. no issues.

District #4 meter runs in both directions. Check valve needs to be installed. For now, we will go off the house meter readings every quarter.

Brush Grinding Quote

Highway Supervisor Sokolofsky distributed a quote from GreenRenewable Inc., for grinding of brush pile at the Highway Garage. Green Renewable of Manchester will provide loader, grinder, excavator, and operator and remove all processed material promptly. Contract Agreement choices: one- year \$1,000 (7/1/2021 to 7/1/2022) or three- year no cost (7/1/2021 to 7/1/2024). The board agreed to sign the three-year contract upon motion by Councilperson Carey, seconded by Councilperson Mayer, the vote went as follows:

Water District #5

Supervisor Falk stated CPL engineers are ready to move forward with conducting the survey online and mailing. Upon motion by Councilperson Belec to move forward, seconded by Councilperson Carey, the vote was unanimous.

Employee Health Insurance

After discussion, the board agreed to increase Towns % of Health Insurance costs from 75% coverage for employees to 95% coverage. Supervisor Falk will calculate numbers and circulate to the board.

Supplies Needed for a Pandemic & Storage

Supervisor Falk will request masks and hand sanitizer to store at Town Hall should there be another pandemic.

Cemetery Concern Received

Supervisor Falk mentioned receipt of a concern located in the Lima Presbyterian Church. Said concern is below:

Concerning: Cemetery behind Presbyterian Church

I'm concerned about the cemetery located behind the Lima Presbyterian Church. This is one of the oldest, if not the oldest cemetery in Lima. Manasseh Leech, the first Town Supervisor, and Josiah Leech, the third Town Supervisor, and their families are buried in this cemetery. Many veterans, including two who served in the Revolutionary War and one who served in the War of 1812, are buried here. As you walk through the cemetery you will recognize many familiar names.

My concern has to do with the condition of the cemetery and one of the causes of damage to many headstones. Over the last few years, several trees and large dead branches have fallen and have done considerable damage. Currently there are 2 very tall dead trees and several old trees.







After discussion, Highway Superintendent Sokolofsky and Councilperson Carey to find documents explaining what the procedure is to receive funds from the State. Light Up Livingston Grant

Supervisor Falk informed the board Senator Charles Schumer spoke Tuesday afternoon at Mulligan Farms, Avon, announcing a 11.3 million grant to a public-private partnership between Livingston County and Empire Access to create a network expected to deliver broadband internet to more than 11,000 residents, nearly 100 farms and more than 40 businesses.

Water Rate Increase

Supervisor Falk distributed last years rates increases. He suggested the following increases:

- For all Districts: Change District #1 unit fee to \$10 and the rest of the districts remain the same at a quarterly fee of \$45 per unit.
- A quarterly fee of \$45.00 per unit
 - \circ 5/8" Meter = 1 unit
 - 1" Meter = 2 units
 - o 2" Meter = 3 units
- Water District #2 and #4 \$6.80 per 1,000 gallons of water usage, also charged quarterly (up from \$6.70)
- Water District#1 and #3 \$6.05 per 1,000 gallons of water usage, also charged quarterly (no increase)

The board agreed to said changes and upon motion by Councilperson Mayer to hold a public hearing at the August 3rd meeting, seconded by Councilperson Carey, the vote went as follows:
